### 1 | Rules

This section outlines the **general rules** for each giveaway. Any special rules will be added to this section on a situational basis.

- 1. All entries must be 18 years old or older to enter. Any entries from people younger than 18 years old must have consent from a parent or legal guardian.
- 2. Each giveaway will be announced on this website and on all social media platforms. All social media platforms will only get a brief description and advertisement of the specific giveaway and how to enter it. Full details will be found on the **Chasmic Desist** website in conjunction with the general details provided in this document.
- 3. Each giveaway will be promoted over a time span of **2-4 weeks** unless indicated otherwise.
- 4. As the giveaway is promoted, all entrants will be given **ONE** (1) discount code to be used on the specific giveaway item(s) in the **Chasmic Desist Store** until the giveaway ends.
- 5. Each giveaway will have 2-3 winners unless stated otherwise. Due to the more personal nature of the giveaway, additional delivery time will be added to the general shipping time for each item. For more detailed information regarding this aspect of the giveaway, please see the <u>Current Restrictions</u> section.
- 6. Each winner will receive a form (via email or direct message) asking for their sizes (if applicable) and shipping information so that they may receive their item(s). Each winner is expected to complete and send this form back to me in a timely manner (approximately 1-2 weeks at MAX). Any time greater than this period will be considered a forfeiture of winnings. Any special circumstances will be considered on a situational basis.
- 7. At the end of each giveaway, the winners will be announced and displayed on the **Chasmic Desist Giveaways** page and all social media platforms.
- 8. Chasmic Desist is not a postal service. Chasmic Desist is not responsible for any goods that are damaged or lost during the shipping process. In the event that a winner receives damaged goods or does not receive their goods at all, they will be given ONE (1) ONE-TIME USE 100% OFF DISCOUNT CODE that is only applicable to the giveaway item(s) at checkout. This code will expire in 1-2 weeks, but special circumstances may alter this expiration date. Any winner that meets the circumstances associated with this rule will be required to present reasonably substantial evidence of damaged or lost merchandise in order to receive the code.
- 9. Once the giveaway has ended, all promotions will end, and the **Chasmic Desist Giveaways** page will be updated to show its results and termination.

### 2 | Regulations

This section outlines the **general regulations** for each giveaway. Any special regulations will be added to this section on a situational basis.

- 1. All winners are chosen at **random**. Once entered into the giveaway, each entry is placed into a pool from which the winners will be selected at random when the promotional period has ended.
- 2. No winner is required to accept their gift. If they choose not to accept it or they are unable to within the timespan outlined in the <u>Rules</u> section, then they will be granted the following options:
  - a. Unable To Accept: In the event that a winner is unable to accept their gift, they will be provided ONE (1) ONE-TIME USE 100% OFF DISCOUNT CODE that is only applicable to the giveaway item(s) at checkout. This code will expire in 1-2 weeks. Special circumstances may alter this expiration date.
  - b. Choosing Not To Accept: In the event that a winner chooses not to accept their gift, they will be given an additional 20% off discount code that expires in a week, and another entry will be chosen at random. If the alternate winner does not accept or respond within 1-2 weeks, then the number of official winners for the giveaway (those who have accepted their gift or those who want it but are unable to accept it) will be reduced to the number that has not chosen this option and the alternate winner will receive an additional 20% off discount code that expires in a week (if they decline the gift).

This event will only occur if it is **transparently clear** that the winner will not or can not accept their gift.

- 3. All products and giveaway items are available for US shipping only. See the <u>Current</u> <u>Restrictions</u> section for more information.
- 4. No giveaway will ever be pay-to-win. This is not a lottery. All giveaways are purely meant to increase the audience of **Chasmic Desist** as well as perform acts of kindness. Every giveaway is free to enter.
- 5. All entrees get one slot. Nobody can enter the same giveaway more than once.

### 3 | Current Restrictions

#### 3.1 Shipping Policies

Due to the current trademark restrictions for **Chasmic Desist**, all products can only be bought and sold in the **US and its territories**. This means that all products, including giveaway items, will only be shipped throughout the **US and its territories**. Although no customer residing in a foreign country will be able to buy anything at this time, this is not a permanent shipping policy and will be updated when possible. Therefore, please be patient until that occurs. For a more detailed explanation regarding **General Shipping Policies**, please go to the **Shipping Policies Page**.

#### 3.2 Time Constraints

The more personal nature of these giveaways necessitates that additional time be made in shipping giveaway winners' items to myself first so that I may personally package them in their specially made giveaway boxes and ship them to the winners. As such, in addition to the normal production and shipping timelines outlined in the **Shipping Policies Page**, extra time will be added to the delivery process. Although this additional time is largely dependent on postal services and my ability to package everything appropriately, please rest assured that I will get all items to winners as expeditiously as possible and will provide updates and tracking information to each winner. For more detailed information regarding how the vendors for all Chasmic Desist products impact the shipping process, please see the section below.

#### 3.3 Vendor Updates

At its core, **Chasmic Desist** is a dropshipping business whose primary products are attained from a third-party vendor in **Printful**. The shipping policies and timelines of **Printful** directly influence the delivery times and taxes on all primary products associated with **Chasmic Desist**. Any specialty products not associated with **Printful** and/or other dropshipping vendor(s) will be indicated on the **Shipping Policies Page**. Due to the current desires, needs, and vision that I have for **Chasmic Desist**, **Chasmic Desist** will primarily remain a dropshipping business until further notice. If it is determined that inventory better suits the growth of **Chasmic Desist**, then changes will be made accordingly.
